Installation of hydrants ahead of pace

County workers have installed 90 of the 150 fire hydrants approved by voters last year

It all started with voters going to the polls last March.

Less than a year later, the voter-approved Special Purpose Local Option Sales Tax will pay for approximately 150 new fire hydrants which will greatly reduce the county's ISO rating to a Class 5 in many areas, Towns County Sole Commissioner Bill Kendall said.

The installation of those hydrants is well ahead of pace. To date, 90 of the 150 fire hydrants approved by voters have been installed, said Marty Roberts, Towns' 911 Mapping Director, who is helping to oversee the project along with Fire Chief Mitch Floyd.

The first hydrant was installed on July 7th. To date, 90 fire hydrants have been installed. That's mov-

ing pretty fast, said Roberts. "If we'd had pretty weather, we could have installed a lot more," Roberts said.

Roberts said that the county has no timeline to finish the project due to weather concerns.

"Overall, we'd like to have them installed by spring," Roberts said.

Close proximity to a fire hydrant saved a condominium in Hawks Harbor on Sunday.

"If it hadn't been as close to a hydrant as it was, it would have been gone," Roberts said. "It was a windblown fire that was extremely dangerous and difficult to extinguish. Good work by firefighters and I'm glad they had plenty of water to work with."

The county has 28 more hydrants to install be-

Senior Center going up fast

A Chad Winkler promise is as good as gold.

Winkler & Winkler Construction out of Blairsville broke ground on the new Towns County Senior Center in early November. At the time, Winkler said that weather-permitting, the project would be completed in 180 days.

Even with all the wet weather the region is experiencing, Winkler & Winkler Construction is well on its way to completing the 5,800 square foot Senior Center on time.

With the front entrance and back porch included, the facility will be around 7,000 square feet.

And Winkler promises that there isn't another Senior Center around that will have the back porch view that the Towns County Senior Center will have. It

The General Primary will be held on July 31st and the General Election will be held on Nov. 6th, Shook said.

Sheriff: 'No word yet' on ID

Towns County sheriff's authorities continue to await word from the Georgia Bureau of Investigation's Crime Laboratory as to the identity of human remains found in southern Towns County on Jan. 15th Sheriff Chris Clinton said.

Sheriff Clinton said that his department had yet to receive word regarding the identity of the human remains discovered near the Appalachian Trail.

"We're still awaiting word from the GBI and the state crime lab," Sheriff Clinton said. "We don't have anything new to share at this time. We hope to have something later in the week."

On Sunday, Jan. 15, small game hunters discovered what they believed to be human remains on U.S. Forest Service land near the Appalachian Trail. They made contact with the Towns County Sheriff's Office about their discovery. Towns County Sheriff's Lt.

Brian Wilson and Deputy Doug Lloyd and a DNR ranger were the first authorities to arrive at the scene. The officers determined that the find was indeed human remains.

A call to Sheriff Clinton prompted a call from the sheriff to the GBI to assist in the investigation.

Towns County Deputies and DNR rangers secured the scene and were joined by U.S. Forest Service law enforcement and GBI as they began a search

Grand Jury Indictments

Towns Grand Jurors hand up 11 true bills

Towns County Clerk of Court Cecil Dye has released the following indictments by Towns County Grand Jurors:

• Charles Kenneth Gray Sr.: Felony attempt or conspiracy to violate Georgia's Controlled Substance Act;

• Erik Steven Underwood: Aggravated stalking; battery; cruelty to children – allow to witness felony/battery/Family Violence – third degree;

• Kendrick Lamar Hillsman: Terroristic threats and acts; battery – Family Violence (first offense) misdemeanor; simple battery – Family Violence;

• Alisha Marie Williams: False statements or writings; conceal facts or fraudulent documents in matters of government;
