### **County agrees to rent** land for recreation

Always in search of property for additional athletic fields, Towns County Sole Commissioner Bill Kendall has agreed to lease property from the Industrial Development Authority for the Towns County Recreation Department.

"It is common knowledge that we don't have enough athletic fields," Commissioner Kendall said. "I got together with the Industrial Authority and they have agreed to lease unused property for the use of temporary athletic fields.7

Commissioner Kendall, Authority Chairman Morris Phillips and the entire Industrial Authority Board, as well as Wes Hooper, Towns County Recreation Director, all expressed their full support for this move as a temporary fix for the need of athletic fields Towns County youth.

However, both Kendall and Phillips emphasized that



the Industrial Park Property must be retained for Industrial Development while the authority continues to work to bring in much-needed jobs for Towns County residents.

"The lease agreement states that either party may terminate the lease with a 30-day notice," Commissioner Kendall said.

During his campaign for Sole Commissioner, Kendall expressed the need
