SPLOST firefighting projects will save residents \$\$\$

A \$94,000 grant with a 5 percent County match will pay for 35 sets of new turnout gear for local firefighters. Towns County Sole Commissioner Bill Kendall opened the bids last week, which ranged from \$56,600 to \$67,375.

The turnout gear is just one phase of lowering the county's ISO rating and reaching the 2.6 points that separates the county from a Class 5 fire rating. Additional phases will be handled through the implementation of the voter-approved Special Purpose Local Option Sales Tax.

"It'll save homeowners a lot of money each year on their homeowners insurance," said Towns County Assistant Fire Chief Harold Copeland, during last week's

commission meeting at the Towns County Courthouse.

"I talked with a lady recently whose insurance company thought she was more than five miles away from a fire hydrant," Copeland said. "Her homeowners insurance went from \$360 a year to more than \$900. It turns out that she actually was closer than five miles from a fire hydrant."

The voter-approved SPLOST will pay for approximately 135 to 150 or so new fire hydrants which will greatly reduce the county's ISO rating to a Class 5 in many areas, Fire Chief Mitch Floyd told residents attending last week's commission meeting at the Towns County Courthouse.

"Marty Roberts (911 mapping) played a huge role in locating where the hydrants will best be utilized," Chief Floyd said. "It'll prob-

ably be 12 months before we get up to speed with the fire hydrants. This is going to mean a lot to us."

Commissioner Kendall praised locals for turning out to support the SPLOST on March 15 during the special election.

"It was an outstanding vote (90 percent approval) and I think that speaks volumes for Towns County citizens," he said. "We had a lot of good organizations supporting us. There were a lot of good projects out there to support that will

benefit the county.

"We look forward to getting these good projects underway," Commissioner Kendall said. "Now that the SPLOST referendum is behind us, we will hit the ground running with the hard work needed to implement these projects over the six year life of the SPLOST."

Collection of the SPLOST begins July 1, the day following the expiration of the Towns County Board of Education's ELOST.

The cities of Young Harris and Hiawassee will receive 9 percent each from SPLOST proceeds. Once the projects are paid for, anything left over will be used to roll back taxes.

County projects include parks and recreation improvements that include acquisition, construction and equipping a multi-purpose recreational and community building. It also includes

money for roads and bridges improvements and may include pedestrian crosswalks, parking and capital equipment.

Fire Department improvements also are on the list of capital outlay projects to include vehicles, equipment facilities and fire hydrants. Other projects include construction and improvements at public libraries, water and sewer improvements, including solid waste, stormwater management and accompanying equipment.

Public safety vehicles and equipment including ambulances also are high on the list of capital projects.

The SPLOST also includes funds for industrial and economic development.

The county also has secured sewer capacity from the city of Hiawassee via an intergovernmental agreement.

GDOT invites public to May 5th meeting

GA 515 Information hearing at Young Harris College

It's not I-3, it's funded 80 percent by the federal government and it's not etched in stone.

That's what Georgia Department of Transportation officials told stakeholders and members of the general public last week at Young Harris College regarding the proposed expansion of GA 515/U.S. 76.

A public information hearing regarding the proposed 8.3-mile widening project from Blairsville to Young Harris is scheduled for May 3rd in Blairsville at 165 Welborn Street, better known as Haralson Memorial Civic Center.

Robert Mahoney, district preconstruction engineer, told the group meeting

at Young Harris College that the federal government has the final say about the project.

"They own the environmental study," Mahoney said. "The environmental study will predetermine the scope of this project."

That's because if one penny of federal money is spent on a road project, the federal government has the final say.

Mahoney told the group of more than 60 people gathered in the Goolsby Building at Young Harris College that the project was necessary to handle the growth in traffic from Blairsville through Young Harris for the next 20 years.

The Needs Analysis for the proposed project will

Chuck Negrone looked energetic, his voice was powerful and his tunes were all so familiar.

It ended with Negrone belting out Three Dog Night's legendary *Joy To The World*, but not before it appeared he had left the stage to a standing ovation.

He returned to center stage to sing one of Three Dog Night's most signature hits to bring the show and the eventful evening to a close.

Negrone has been touring with Blood, Sweat and

Tears since 2005 and when Paparozzi left the stage, the band welcomed Negrone to center stage. They provided the music and Negrone belted out the songs.

The list of hits by Three Dog Night is so long and memorable, Negrone actually would have had to sing all night long just to complete the checklist.

On this night, he took the audience on a trip down memory lane. He sang *One*, the hit song and title track of Three Dog Night's debut album in 1968. Negrone sang
