

Now, we must continue the collections process with the remaining 8% who are delinquent on property taxes. I realize and understand that many customers have had tough times this year, but regardless, you have a bill and all bills must

be paid.

During the remainder of June, my office will be preparing and mailing delinquent notices. Please do not take the notices lightly, as we will be actively pursuing collections.

## The Middle Path

Our memory for history is short and our attention span is even shorter for historical perspective on current events. Headlines again decry the "crisis in leadership" that we face today but if there is any truth in headlines, the crisis extends back in time to the beginnings of our history as a nation. Even someone allergic to dusty old history books can remember that some of the catchy phrases being used to confront Barack Obama have been recycled from the Bush years. "Obama's Katrina" is just one of the cheesy captions being used to describe the president's response, or lack of it, to the Gulf oil spill.

Some have compared today's wide range of problems to the challenges faced by the declining Roman Empire. The Romans struggled to pay for maintaining a military presence at the far flung corners of their empire and this economic challenge was exacerbated by corruption in their government.

One can easily find parallels to modern times, but if you searched the annals of history from yesterday's newspaper to the beginning chapters of the Bible, you would be hard pressed to find a time when corruption was not a problem and leadership was not in crisis.

Yet empires do decline and nations fall and being creatures of some reason, we seek explanations when things change. Historians do not agree on cause and effect for the rise and fall of nations.

Modern thinkers do not agree on the evolution or devolution of American society, but where we do find general agreement is among the general population where we live the lives behind the statistics. The majority of us are troubled indeed and for the first time in modern history our children are unlikely to be as well off as their parents.

There are no easy answers to be found in the historical record, but as one born at the end of the Baby Boomer generation, I have lived long enough to see a new generation waiting in the wings and to perceive some changes that have happened in my own lifetime. The one change that I believe bears most directly on the problems we face today is the systemic decline in integrity that can be found all the way from Main Street to Pennsylvania Avenue.

I'm not talking about religion or even morality here. The German people before WWII were among the most religious and moral (and best educated) people of their time, but that did not save them from disaster. By "integrity" I mean truthfulness and consistency in principles. Integrity is what

holds a society together and while there have always been liars and thieves in every walk of life and though governments have always lied in varying degrees, arguably when the national integrity drops below a certain threshold, decline is imminent.

I can think of very few political campaigns in living memory where the truth was not bent or broken. I can think of no administration which did not at some point attempt to deceive the American people. What seems different, however, is the lack of offense we now take to the lies that accompany politics and governing like thunder accompanies lightning.

What seems different is the level of corruption that engenders the lie, corruption that is found not only in government but in business all the way from the small corporation which can be manipulated to enrich a few individuals to the large multinational that can pick the pockets of an entire generation, also for the benefit of the few. We have all heard the story of the CEO's given millions in bonus pay, some even after bankrupting their company. Most of us have seen an incompetent supervisor promoted despite his performance because of nepotism or political connections.

What seems different now is the frequency with which these stories arise.


Perhaps part of the problem is the hierarchical structure of the corporation.

In a democracy or a republic, theoretically, power is derived from the people and when malfeasance is found in leadership circles it can be weeded out by election if not by due process of law. In a corporation, however, power is wielded by a CEO and a Board of Directors and the influence of stockholders is distant or diluted. There are few checks and balances on the power concentrated into a few hands inside a corporation and the integrity of the company depends on the integrity of a relatively few individuals.

When corporate power gets into bed with government power and integrity is an issue, one of the results can be seen washing up on the shores of Louisiana.

As for the decline in integrity, volumes could be written on the subject, and while we might argue over the root cause, some of the mechanism, at least, seems clear.

We are a generation brought up to "create our own reality" and we are saturated by media which reinforces that idea. We worship celebrity and we are reminded at all times of the excesses, the affairs and the crimes of these awful role models, our precious actors, sports figures and politicians. We observe that, at least for these special people, there seems to be no consequence for their actions. We know it isn't fair. We all want to be special. We all want to be the "Golden Child," and when we are presented with examples on a daily, even hourly basis of people who act with no consequence, for some of us it becomes easier to cheat on our taxes, to cut corners, to fish off the company dock or to try and change the reality of our actions by talking it away. We can do this as individuals or we can do it as a nation, but there is a reality no amount of talk or spin will change. That reality is standing in line at the unemployment office. That reality is rotting in the marshes of Louisiana. Lack of integrity helped to create it. We ignore it at our own peril.


