On a super fast Tri-County Race Track, Morganton driver Bobby Panter and Warne's Danny Ledford raced to a one-two Late Model finish Saturday night. Panter and Ledford set the two fastest times and battled each other to the first turn with Panter taking the point and holding it all the way in the 25 lap feature. Following Panter and Ledford across the finish line were Jacob Anderson, Preston Crisp and Doug Sneed in the top five.

Copperhill driver Jason Deal made a quick move in the GM Performance Late Model feature and visited Victory Lane in front of Hiwassee's Kevin Bradshaw, Kevin Sutton, Kurt English, Young Harris's Tony Ledford and Sam Parris.

In what has become the most competitive race of the night, Brasstown's Greg Sudderth raced to victory in the 13 car field in front of Murphy's Charles Devine, Brad Thomas, Mike Bryson and Sammy Berong in the top five. June 25, 2010, Blue Ridge, GA ~ Lucy McKenzie of Murphy, NC brought some special gifts with her to an appointment with Dr. Whaley at the Georgia Cancer Center at Riverstone. With a little help from her family and friends Lucy McKenzie paid it forward with the "Lucy Mac Sac".

Lucy Mac started chemotherapy back in November 2006. This past February, the disappointing news came that it transitioned to acute myeloid leukemia and she had to stop working for Meridian Behavioral Health in Marble, NC. The cancer may have stopped Lucy Mac from working, but it couldn't stop her from helping people!!! Along with her daughters, Carol Lee and Mary Lynn, Lucy created the "Lucy Mac Sac" to give as gifts to the folks who are starting or continuing chemo treatments. "I feel this would have helped me," Lucy says in the booklet inserted in the "Lucy Mac Sac".

The "Lucy Mac Sac" for the ladies is a cheerful fashionable handbag and for the men a masculine reusable grocery bag. From Lucy's experience she chose some simple, but helpful contents such as a fluffy little pillow she says feels really good right behind your neck for those long chemo treatments, soft hats for the ladies, a roll of LifeSavers, anti-bacterial hand soap, hand lotion, and her booklet with positive quotes and pages to take notes and the cutest, softest little black bear donated by Rountree's Furniture & Accessories in Blairsville, with their prayers and wishes attached! Lucy Mac's 6-year-old grand daughter, Jayden, put the bags together and is also a contributor on the inside back cover of the booklet.

Lucy's daughter, Mary Lynn Durfee started gathering the contents and found that there are so many others who are touched by cancer themselves or a close family member or friend that it turned into a joint venture with many people! First, the handbags were seriously discounted by a client of Mary Lynn's, Bonnie Wild of "Accessories Gone Wild" who resides in Florida

and has a cabin in Hayesville, NC. Then the pillows and hats came from Jay Otrhalik of Leetsdale, PA for a donation and the shipping was paid for by Lori Glaze, who also suggested that instead of Lucy and her daughters taking all the cost on themselves, that they allow others to participate and that's where the sponsorship began. Extension Tips



Plan ahead for home canning

If you are thinking about joining the trend in our communities to can food this summer, start by checking your equipment and supplies. Proper equipment in good condition is essential for safe, high quality home canned food.

A pressure canner is essential for canning low-acid vegetables, meats, fish, and poultry. Two basic types are available. One has a dial gauge to indicate the pressure inside the canner; the other has a metal weighted gauge. Dial gauges must be tested for accuracy before each canning season. For information on testing a dial gauge, call your county Extension agent. Check the rubber gasket; it should be flexible and soft, not brittle, sticky or cracked. Also make sure any small pipes with openings are clean and open all the way through.

A boiling water canner is needed for canning other foods such as fruits, pickles, jellies and jams. The canner should be deep enough to allow at least one inch of water to boil over the tops of the jars. Both types of canners should have a rack in the bottom to keep jars off the bottom of the canner.

Inventory your jars and decide if you need to buy new jars this year. Inspect those you have for nicks, cracks or chips, especially around the top sealing edge. Nicks can prevent lids from sealing. Very old jars can weaken with age and use and break under pressure and heat. Consider investing in new jars if you need to, and watch for specials.

A must@ every canning season is new flat lids. Used lids should be thrown away. The screw bands are reusable if they are not bent, dented or rusted.

A FINAL MUST@ is reliable, UP-TO-DATE canning instructions. Publications and information are available at your county Extension office.

The University of Georgia Cooperative Extension Service also sells SO EASY TO PRESERVE, a comprehensive book with information on all types of home food preservation. Information about that book is also available for order at your county Extension office.

Be sure to look at the instructions for what you want to can before you are ready to prepare the food. You may need time to purchase some ingredients and small equipment needed to prepare food exactly as the directions indicate. Planning ahead can save you time, money, and frustration with home canning. TUJul14,J1JSH

Green beans and more seminar



Have you ever wanted to know more about growing green beans and other vegetables organically? Well you are in luck. In conjunction with the first ever Blairsville Green Bean Festival, the Georgia Mountain Research & Education Center and the Community Council are hosting a seminar for homeowners on growing organic vegetables. Weather permitting, seminar attendees will be able to tour the organic green bean trials at the GMRE Center.

Our speaker is Ms. Amanda Tedrow. Amanda is the current Athens-Clarke County Agriculture and Natural Resources Extension Agent. She received her undergraduate degree in horticulture from UGA. During and after graduating she worked at numerous plant nurseries in the Athens Area. She was then hired as the curator of the Shade and Native Flora gardens at the State Botanical Garden of Georgia. In addition to her work with Extension she is now pursuing her Masters in Plant Protection and Pest Management. She teaches Master Gardener classes, works with local homeowners and farmers, and helps coordinate the Athens Farmers Market.

This free seminar will take place at the Georgia Mountain Research & Education Center. The GMRE Center is located three miles south

of Blairsville, on the east side of Hwy 19/129. There is no cost for this seminar and no pre-registration is necessary. However, seating is limited to the first 100 in attendance.

This seminar is the 77th in a series of seminars sponsored by the Outreach Committee of the Community Council. The Community Council was formed in 2003 to expand the outreach and service of the Georgia Mountain Research & Education Center to the mountain region. To fulfill this purpose, volunteers work through three program committees - Preservation, Education and Outreach. The Outreach Committee began offering free seminars in 2004. Since that first seminar, more than 5,300 adults have benefited from these seminars. The operating budget of the Community Council is funded by gifts from friends through an annual campaign.


Contra concert at Folk School
