and wearing of masks. Voters are encouraged but not required to wear facial coverings, which will be made available alongside hand sanitizer.

The Nov. 3 ballot features contested elections for the following federal, state and local offices: President of the United States; two U.S. Senate races; two Public Service Commissioner races: the 9th Congressional District seat; District 50 State Senator; 8th District State Representative; and Towns County Tax Commissioner.

Also on the ballot are uncontested elections for five local offices, including Probate Judge, Clerk of Superior Court, Sheriff, Coroner and Commissioner, and no one is running for Blue Ridge Mountain Soil and Water Conservation District Supervisor.

The General Election features three statewide ballot initiatives for all Georgians to decide, including two proposed constitutional amendments and a referendum.

Amendment 1, if passed, would enable state legislators to use specifically imposed fees and taxes expressly for their intended purposes.

"For decades, the General Assembly has imposed fees for a variety of purposes, only to use the revenue for something else," according to David Wickert of The Atlanta Journal-Constitution. "For example, the state charges for

cards, but they must show a valid photo ID to vote.

Registered voters who will be at least 18 years of age by Election Day are eligible to vote during early voting, though Oct. 5 was the registration deadline for voters looking to participate in the Nov. 3 election.

Absentee ballots are being automatically mailed to voters who informed the Board Office they were elderly or disabled on a previous application, though all others need to apply to get their mail-in absentee ballot for the

General Election. People may request mail-in absentee ballots by visiting https://ballotrequest. sos.ga.gov, calling the local Board Office at 706-896-4353 or swinging by the office at Lakeview Circle.

After requesting a ballot, voters can easily track its progress in the mail by visiting https://georgia.ballottrax.net/ voter/.

"BallotTrax is a secure software application that locates ballot envelopes,' according to the service. "The system works with election officials and the Postal Office to send you messages when vour ballot is received as well as notifies you if there is a discrepancy (such as verifying a ballot signature).

"By logging into the BallotTrax site, voters can see their mail-in ballot status and For example, for the Nov. 3 sign up for alerts. The signup election, voters will not be process is simple. ballots to arrive in the mail and potentially several more for completed ballots to be returned for counting when mailed, so it's best to request one well in advance of the deadline.

An absentee ballot/ application must be submitted by the requesting voter, except for a disabled person, who may have a relative by blood or marriage return his or her absentee ballot/application.

Those who receive an absentee ballot by mail but decide to vote in person will need to have their absentee ballot canceled at time of voting.

Election officials have said double voting is not a concern, as the system will alert poll workers if a voter has, for example, already cast an absentee-by-mail ballot but forgets and shows up at their regular voting precinct on Election Day.

Voters can access the My Voter Page at mvp.sos. ga.gov ahead of the election for information on voter registration status, mail-in application and ballot status, poll location, registration information on file with the county office, sample ballots and more

every new tire sold in Georgia. and the money is supposed to be used to clean up illegal dumps and fund other waste management programs.

"But lawmakers have dedicated only a portion of the money for those purposes. Since 2009 they have used more than \$50 million of the revenue for other programs, according to the Association County Commissioners of Georgia.

'Under current law, the only way to ensure a tax or fee is used for its intended purpose is for voters to dedicate the revenue through constitutional amendments. Amendment 1 would allow the General Assembly to dedicate fees and taxes for specific purposes."

Amendment 2, if passed, 'would restore citizens' rights to file lawsuits to overturn unconstitutional laws without the consent of (state and federal) governments," Wickert wrote.

Statewide Referendum A "establishes a tax exemption for certain real property owned by charities," according to the ballot.

"The measure would exempt from taxes property owned by charities for the purpose of building or repairing single-family homes to be financed by the charity and sold to individuals using nointerest loans," Wickert said. "The referendum is aimed at providing a tax break to charities such as Habitat for Humanity. Once the property is sold to an individual, it would be taxed at fair-market value.'

Election Day will be Tuesday, Nov. 3, from 7 a.m. to 7 p.m. That day, voters should report to one of the three preassigned Towns County voting precincts: Hiawassee at the Civic Center; Young Harris at the Lodge Hall Building, aka Stephens Lodge; and Macedonia at Macedonia Baptist Church.

Voters are not required to bring their mailed precinct

People wanting to fill out their absentee ballots/ applications and drop them off in person can do so either with the Board Office directly or at the security-monitored drop box outside the office.

The current deadline to return absentee-by-mail ballots for counting is 7 p.m. on Nov. 3, though this may be subject to change.

In reporting by AJC's Mark Niesse, a federal appeals court on Friday "reinstated an Election Day deadline for Georgia voters to return their absentee ballots, overriding a judge's decision that would have given voters three additional days during the coronavirus pandemic.'

"A three-judge panel of the 11th U.S. Circuit Court of Appeals decided 2-1 to grant a stay of a judge's ruling to count ballots postmarked by Nov. 3 and received at county election offices by the following Friday," Niesse said. "The decision restored a state law setting Georgia's absentee ballot deadline at 7 p.m. on Election Day.

"The ruling will likely disqualify thousands of absentee ballots mailed close to Nov. 3 and delivered afterward by the U.S. Postal Service."

The deadline to request an absentee ballot is Oct. 30. Voters should be aware it could take days for requested
