Witnesses recount thousands of pills, sex-for-drugs in federal court case

GAINESVILLE Flanked by their lawyers, Dr. James Heaton and former Union General Hospital CEO Mike Gowder faced off against Assistant U.S. Attorneys William McKinnon Jr. and Laurel Boatright in U.S. District Judge Richard Story's courtroom starting Tuesday, Oct. 15. Both men are accused of crimes involving prescription drugs, including conspiracy to dispense and distribute controlled substances "outside the usual course of professional medical practice and for no legitimate medical purpose." The 103 charges against them include allegations by the government "misrepresentation,





Library board casts unanimous vote to terminate director's employment

BLAIRSVILLE - The Mountain Regional Library System Board of Trustees voted unanimously last week to terminate the employment of Vince Stone as director of the three-county library system effective Oct. 15.

Library board trustees decided Stone's fate in a called meeting at the Union County Public Library on Tuesday, Oct. 15, making the motion to separate Stone as director "in an effort to move the system in a direction that better meets the needs of our communities."

At the time of the board's

decision, the departing library director had been away from the job for several months for personal reasons, according to the board, with Interim Regional Director Claudia Gibson having served in that capacity since Aug. 1.

"The trustees, the library staff and our communities have expressed the desire for MRLS to emphasize traditional library services that are responsive to each community's needs,' Board Chair Paula Whitehead said following the meeting.

Continued Whitehead, "It was the consensus of the trustees that Mr. Stone is not the best person to lead the system in this direction. We appreciate

his service and enthusiasm and wish him all the best in his future endeavors."

Stone has helmed the libraries of Union, Towns and Fannin counties since March 2015, and he was notified that he had been let go from his position "as soon as possible after the board took action," the board said last week.

In recent years, Stone had pursued a number of new ventures at the libraries, including the creation of the "Mountain Regional Library Puppet Company" and the making of YouTube videos and audio podcasts.

Crash on Georgia 75 likely caused by fatal heart attack, authorities say

Authorities believe that Hiawassee resident Glyn "Dale" Pollard, 83, suffered a fatal cardiac event while driving his vehicle up Georgia 75 the evening of Oct. 16.

Towns County E-911 received a call around 8 p.m. that Wednesday from a motorist who'd seen what turned out to be Pollard's vehicle about 30 feet down the side of Unicoi Mountain.

Pollard had been making his way north toward Hiawassee when his vehicle suddenly left the road and went over an embankment about a mile from the Towns/White County line, according to authorities.

Given Pollard's age and the fact that it appeared as though he never attempted to avoid the accident by swerving or applying his brakes, authorities have determined that Pollard likely died from a

heart attack before his vehicle ever exited the roadway.

An official report by the Georgia State Patrol is expected this week

Funeral services for Pollard took place on Monday, Oct. 21, at Macedonia Baptist Church, with Revs. Wade Lott and Bradley Thomas officiating

According to his obituary, Pollard was a family man who built a career in sales, including time with Atlanta Gas Light, and he served as a longstanding member of Macedonia Baptist Church.

"He was a talented woodworker, and he used that God-given gift to make over 280 footstools for the children of Macedonia over the years," according to his obituary. "In his younger years, he enjoyed golfing and playing pool, at which he won many tournaments.

"Dale loved people; he was funny and fun to be around.

He was known to say, 'You may not like me, but you will never forget me.

Pollard is proceeded in death by his parents, daughter DeAnn O'Kelley, three brothers and two sisters.
