## Fiddle Queen reigns supreme at Fall Festival

The third time was a charm for the future of Bluegrass.

Ivy Phillips of Chapmansboro, Tennessee, is a multi-talented multi-instrumentalist, and she showed that Friday and Saturday at the Annual Georgia State Fiddlers' Convention at Anderson Music Hall.

She became the Georgia State Champion Dobro player, and her Bluegrass band, The Trailblazers, took the state title as well.

Phillips finished second in Dulcimer and Old Time Banjo, and she's also quite the dancer, claiming Second Place in Buck Dancing.

And yes, she claimed a couple of other state titles on Saturday.

She took First Place in

Junior Fiddle, and for the first time since 2014, the Georgia State Fiddlers' Convention has a Fiddle Queen.

Phillips, 15, has been playing the fiddle since she was 4 years old, and this was her third year competing at the Georgia State Fiddlers' Convention.

"I'm flattered and excited to be the Fiddle Queen," she said. "Winning this title really means a lot to me."

Phillips competed in a fiddle-off with Roy Crawford of Cullman, Alabama, this year's state champion as Senior Fiddler.

Playing Minor Swing, accompanied by the guitar play of Tyler Andal of Nashville, Tennessee, a confident and graceful Phillips finished off one of the top performances of her young career.

"I'm humbled and honored to be the Georgia State

Fiddle Queen," she said. "I'll do my best to get back here next year and defend my title."

Phillips is more than just your average kid from Tennessee. She is an all-around musician and a multi-state fiddle champion.

The young fiddler first became interested in the fiddle after watching her brother take lessons at a local college. Within the next year, at the age of 3, she began to take them, too.

Being homeschooled and working very hard from a young age, she started competing at local festivals and making many Bluegrass friends.

Today, at the age of 15, Phillips has won several state titles and plays in many bands.

She can play all the instruments in a Bluegrass band. After learning the fiddle, See *Fiddle Queen*, Page 6A

ticket for the festival, you get a little beer glass as a souvenir that you can take with you to See *Appalachian Fest*, Page 6A


## Hiawassee responds to EMC letter on franchise fee ordinance

The Blue Ridge must pay franchise fees to the City of Hiawassee, according to a letter from Hiawassee City Attorney Thomas Mitchell to BRMEMC General Manager Jeremy Nelms.

The EMC said in an Oct. 4 letter to the city that it objected to a recently passed franchise fee ordinance as written, which prompted Mitchell to write a letter addressing Nelms' concerns.

"Initially, your letter notes two facts that are self-evident from the law, specifically that the fee will be indicated on the customers' bills and that only city residents will pay," said Mitchell in his letter, dated Oct. 18. "I write,

however, to respond to the other, inaccurate, contentions therein that have apparently created a misunderstanding." Mitchell goes on to

say that the city – via the city charter, state law, and even according to the Georgia Supreme Court – is authorized
