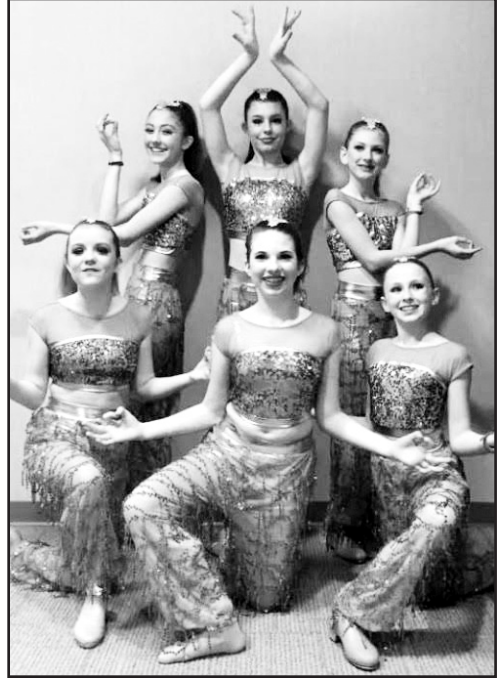

Power Ratings, just three spots below the twenty fourth and final spot for inclusion.

Two of the teams making the public division from Region 4, Taylor County and Macon County, finished fourth and eighth respectively in the Power Ratings and got byes for the first round while four of the remaining six teams got wins in first round play.

Number 10 Hawkinsville rolled past Number 23 Jenkins County of Region 3 by a 77-50 score. Number 12 Crawford County took a 72-65 win over number 21 Terrell County of Region 1. Number 13 Central of Talbotton easily handled Number 20 Irwin County of Region 2 by a 72-49 score, and Number 19 Manchester shocked Number 14 Randolph-Clay of Region 1 by an 85-56 score.

Number 18 Schley County of Region 4 was victimized 68-58 by the Number 15 Indians as described above and Number 24 Dooly County of Region 4 almost pulled off a stunning upset before falling to Number 9 Quitman County 70-67 in

providing one of the most impressive performances by a Region 4 team in first round play.

Quitman had fallen a week earlier by just a 66-63 score in the Region 1 Championship Game to Calhoun County, the Number 2 team under the Power Ratings for the state and the Indians' very formidable opponent with a 25-1 record for this Thursday night.

As for teams in our Region 8 in Class A Private state tournament play, Lakeview Academy finished at Number 2 among private schools and Athens Christian at Number 7 with both getting byes into the second round.

Number 12 Tallulah Falls easily disposed of Number 21 Landmark Christian 69-41 at Tallulah while Number 22 Prince Avenue Christian dropped a 63-41 decision at Whitefield Academy and Number 23 Riverside Military lost by just a 62-55 score at Number 10 First Presbyterian Day of Macon.

One other Class A Private Indians opponent in the state tournament, Number 17 Christian Heritage of Dalton,

fell by just a 49-48 score at Number 16 Mt. Paran Christian.

Of course, most Indians followers are aware that the Indians fell three times to Lakeview Academy and twice to Tallulah Falls while defeating Prince Avenue and Riverside twice each and getting wins over Athens Christian and Christian Heritage in their only meetings with these two teams.

The Indians had clearly qualified for the state tournament through the Power Points procedures prior to the region tournament but for any who wonder if this year's team would have qualified for the state tournament under the rules in effect without the public/private split from the 1999 through the 2012 seasons with two teams from each of the eight regions making it to the state tournament, the answer is yes.

Their win over Prince Avenue in their opening region tournament game would have gotten them in a state tournament with both public and private schools included under the 1999 to 2012 rules in effect.
