The November meeting with Towns County Sole Commissioner Bill Kendall was moved from the county courthouse to the Recreation and Conference Center.

U.S. Forest Service Officer Stan Hinatsu and his team spoke on behalf of the U.S. Forest Service, offering better insight into the Rock Mountain Fire that, along with the Rough Ridge Fire in Fannin County, has become one of the major threats to the region.

In conjunction with the Chattahoochee-Oconee National Forest Service, the fire has been 30 percent contained, with a regulated perimeter just above Towns County, near Hightower Road.

"The area that we have contained is all along the south edge," said Noel Livingston, Incident Commander for the Pacific Northwest Team 3. "This is just along the south border of the fire, though, not the northern perimeter. Currently, the Rock Mountain Fire is around 8,500 acres (as of Nov. 17). The fire has been very active up in the northern peak, up near North Carolina and into the wilderness.

"Right now we have around 350 personnel on the fire, so each team comes with 50 members. I anticipate that we'll be somewhere in the 400 to 500 range before too long though, because of the increasing acreage spread."

Due to the influx of northwestern wind currents, Hinatsu expects this fire will spread north into the North Carolina Nantahala Wilderness, though no homes will be endangered at that juncture.


As of right now, the U.S. Forest Service and all teams involved are primarily focused on maintaining the current containment perimeter of the Rock Mountain Fire. It does not pose an immediate threat to Towns County residents, though all personnel are monitoring the fire closely.

Should the fire become an issue for area residents, Chief Copeland has made assurances that individuals will be notified in enough time to be evacuated efficiently, though he does not foresee this occurring anytime in the near future.


If anyone has health conditions that may be affected by the smoke, the county has 300

N-95 and N-100 masks that are free to the public. These masks can stop either 95 or 100 percent of harmful particles that could be in the air. Anyone interested in one of these masks can pick one up either at the EMS East or EMS West Station.





# Suspect arrested for multiple reports of public indecency in Young Harris

Investigators with the Towns County Sheriff's Office have been busy with an ongoing investigation of reports of public indecency in the Young Harris area.


The first report of an incident of public indecency was reported to have occurred on April 14, 2016, in the Young Harris area.

The second reported incident of public indecency was reported to have occurred on June 26, 2016, on Highway 76 in Young Harris. During this incident, two separate victims reported the suspect had exposed himself.

The last two incidents of public indecency were reported to have occurred during September and October.

On Oct. 28, Towns County Investigators arrested Kyle Edwards, 20, of Blairsville, and charged him with three counts of public indecency.

He made bond on those charges and was released

from the Towns County Sheriff's Detention Center. He is currently being held in the Union County Jail on two counts of public indecency incidents which were reported to have occurred in their county.

Towns County Sheriff's Investigators have two additional warrants stemming from the incidents that occurred on June 26 in Young Harris. The Towns County Sheriff's Office has placed a hold on

Edwards with the Union County Sheriff's Office.

Upon Edwards' release from the Union County Jail, he will be transported back to the Towns County Detention Center to be charged and arrested on the two additional warrants.

The Towns County Sheriff's Office provided assistance to the Young Harris College Police Department and the Union County Sheriff's Office during the course of this investigation.

This investigation continues, and additional arrests are possible. All suspects are innocent until proven guilty in a court of law.
