## **Toddler drowns in pond** off Cynth Creek Road

A 2-year-old boy drowned in a pond on Sunday off Georgia 75 off Cynth Creek Road, Towns County Sheriff Chris Clinton said Sunday.

Towns County deputies responded to Chatuge Regional Ĥospital to a report of a 2-yearold child found in a pond unresponsive.

The pond was located near a residence on Cynth Creek Road in Hiawassee, Sheriff Clinton said.

According to Towns County sheriff's reports, the child was reported to have been outside playing with two older brothers. The mother discovered her 2-year-old son missing and began searching for him.

The child was transported to Chatuge Regional Hospital in Hiawassee by Towns County EMS.

The child was pro-Sheriff Clinton said nounced dead a short time after arriving at the hospital.

The names of the child and family members are being withheld pending notification of relatives

It appears to be an accidental drowning. The incident remains under investigation by the Towns County Sheriff's Office.

'It goes without saying that this is a terrible tragedy," Sheriff Clinton said. "Our hearts break for this child and family. Please keep them lifted up in your thoughts and prayers.

## Hiawassee Council proposes lean budget

Hiawassee City Manager Rick Stancil broke down the proposed \$4.085 million 2014-2015 budget for the City of Hiawassee last week at City Hall on River Street.

The special called meeting, held Wednesday, June 18 by the Hiawassee City Council and the City Manager provided an inside look at next year's budget, looking at city income and anticipated 2014-2015 expenditures.

According to Stancil, General Fund income has decreased from \$1,257,559 in Amended 2012-13 to a proposed \$736,950, a loss in revenue of \$520,609. The proposed 2014-15 Budget assumes that property tax and Local Option Sales Tax income will increase without the need of an increase in millage

The city's current millage is 2.270 and in 2013. 2.270

Initial analysis of Towns County's Tax Digest show's it is on the rise

It could lead to a .022 decrease in the county's millage rate

That's the projection for the tentative 2014 Tax Digest as unveiled by Towns County Sole Commissioner Bill Kendall last week during the monthly county meeting at the Towns County Courthouse.

"We're going to keep a tight rein on spending," Com-missioner Kendall said. "We don't anticipate raising taxes in county government, but, there will be a substantial increase by the Towns County School Board.

The Tax Digest has been on the slide over the past five years because of the recession.

"We lost \$77 million last year on 40 percent assessment," Kendall said. "The actual value of Towns County went down two and a half times that because it's based on 40 percent of market value.

Early projections indi-



**Commissioner Bill Kendall** worth \$7 million more than last year, Kendall said.

"We don't know the exact figure yet, at least it's not going down," he said.

The county's millage rate, although it's not official yet, is projected to drop from 5.622 mills to 5.6 mills.

One mill is equal to \$1 for each \$1,000 in assessed property value; Towns County assesses its property at 40 percent.

The Fire Tax Millage is .5 mills with fire tax revenue at \$357,815, with a total decrease of \$77,802 since 2009.

## Library open house could be in mid-July

The opening of the revamped Towns County Public Library will be one for the books

With its debut just around the corner, Debbie Phillips, branch manager at the Towns County Public Library for almost 23 years, gave a tour of the under construction and almost completed facility that now boasts nearly 8,000 square feet

"We hope about the middle of July to have our Open House," said Phillips. "This building was originally constructed in '88 and was never built for growth, never built for computers

"This is the fastest growing library in our region and we just ran out of space and needed more room," she said.

"It took seven years through our legislative system to get it. The funding was 90 percent state and 10 percent local," Phillips said.

## **Ralston names Allison to study** committee for wrongfully accused

Georgia House Speaker David Ralston (R-Blue Ridge) has appointed House District 8 State Rep. Stephen Allison, (R-Blairsville), to the House Study Committee on Compensating Wrongfully Convicted Persons.

The committee, established by House Resolution 1332 also includes State Rep. Carolyn Hugley (D-Columbus), who will serve as Committee Chair, State Rep. Ben Harbin (R-Evans), State Rep. Rahn Mayo (D-Decatur), and State Rep. B.J. Pak (R-Lilburn).

The committee's task is to determine a uniform method for fairly and reasonably compensating wrongfully convicted persons.

The committee will recommend any actions or legislation that it deems necessary

The committee will study procedures used in other jurisdictions in the United States in an effort to ensure that any person wrongfully convicted in Georgia is compensated fully and fairly.

The committee will publish a report of its findings and recommendations, which may include suggestions for proposed legislation.

The report will be made on or before Dec. 1.

## **Early voting begins June 30 at Old Rock Jail**

Early voting for Towns County's Primary Election runoff begins June 30.

Early voting continues through July 18 at the Towns County Board of Elections and Registration Office at 91 Berrong St. in Hiawassee.

A driver's license is necessary for registered voters to be eligible to vote. Voters also can call the office at (706) 896-4353 to request an absentee ballot be mailed to them.

Voter precincts are the same as the May 20 Primary. Voters going to the incorrect precinct can always vote by provisional ballot. The Elections Office cur-
