## Towns voters shoot down T-SPLOST

Towns County voters said no to the 1-cent regional transportation sales tax, returned Donna Hedden and Bob Gibby to Towns County's Board of Education and supported Doug Collins in the 9th District Congressional race.

Towns voters killed the T-SPLOST with a vote of 2,417 or 89.58 percent to 281, or 10.42 percent during Tuesday's Primary Election.

The turnout was 37.07 percent, with 2,722 registered voters casting ballots.

No one has spoken louder, more vehemently, and more frequently against the proposed 1-cent regional tax increase than Towns County Sole Commissioner Bill Kendall.

"Towns County citizens have spoken loud and clear by defeating the T-SPLOST tax by a resounding 90 percent NO vote against this legislative abomination," Commissioner Kendall said. "I am very happy

for them and extend my thanks for joining in this fight to defeat this unjust tax.

"It has been a long and tiring fight since I cast that only 'no' vote at the T-SPLOST Roundtable asking them to not put this ill conceived tax burden upon our citizens," he said. "At the time of the Roundtable vote, chances looked very bleak of

defeating the power structure and the millions of dollars of special interest money trying to thrust this unfair tax upon our unsuspecting citizens.

"Our proud and independent thinking mountain folks, along with our like-minded new residents, came together

## Authorities seize drugs, paraphernalia and cash

Towns County sheriff's deputies and members of the Appalachian Drug Task Force and a Georgia Probation Officer have arrested a 38-year-old Hiwassee man on drug charges, sheriff's reports show.

The bust went down last Thursday as authorities followed up on an ongoing drug investigation, based on information gathered by Towns County Sheriff's detectives. A Fourth Amendment waiver search was conducted on a probationer at a residence off Highway 75 South in Towns County.

Two agents from the Appalachian Drug Task Force (ADTF), deputies and investigators with Towns County Sheriff's Office and a Georgia Probation Officer, conducted the investigation and arrested James Michael Dickert on multiple charges.

Sheriff's detectives described the scene as an apparent business set up.

At the scene was an office, a desk, money box and a product to be sold, sheriff's reports show.

Seized were bags containing suspected methamphetamine packaged for sale, as well as a larger bag with the same substance, sheriff's reports show.

A pipe ready for use containing suspected metham-

Robinson's Racing Pigs and The Paddling Porkers took center stage to entertain the racing fans attending the Fair over the weekend.

It may not have been the Daytona 500, but these little pigs ran their hearts out for the grand prize of an Oreo cookie.

Dale "Oinkhart Jr." and Jeff "Gorham" were snout to snout for the first three turns until Gorham took the outside line and captured the red and white-checkered flag.

Michael "Wallertrip" was third, followed by Ryan "Newham," who had a little trouble with debris on the track.

The Paddling Porkers were next and this time it was the ladies turn to get in on the action.

Things started a little slow as there was a four-pig pileup in turn one. Officials got things cleared up and the green flag was out as the porkers rounded turn two and headed toward the water.

The ramp was slow this year due to the hot weather and the footing was unstable.

Lindsay "Slowham" reached the top of the ramp first but Brittany "Spare Ribs" hit the water before the other racers could gather their hold on the overheated ramp.

Christina "Hogulara" was determined to win this race but just couldn't pull away from Hillary "Rodham" Clinton as they entered the water with a liberal splash.

"They let us know when it is time to quit racing and we retire them to our farm in Florida," said owner Sharon Ross.

Robinson's Racing Pigs and The Paddling Porkers are owned by Randy and Sharon Ross from Fort White, FL.

They have been in the business since 1985 when the first pig race was designed for the Florida State Fair.

At the conclusion of that Fair, they had 12 bookings for the little inkers and they have never looked back.

They now run five different operations in the United

## Contractors learn bidding process for new park

Friday morning approximately 50 local construction workers and suppliers, some affiliated with a business and some independent contractors, attended a special called Commissioner's Meeting held at the Towns County Courthouse Courtroom.

They were there to learn more about the sub-contract work being offered to 'locals' for the new recreation center that will be constructed on Mining Gap Road.

Each interested individual received an application to complete and submit in which they had the opportunity to describe their particular area of expertise as well as all work related experience.

Commissioner Bill Kendall previously announced that his office is encouraging the use of local sub-contractors and suppliers to construct the 26,000 square foot Foster Memorial Park Recreational and Community Center.

Kendall and the R.W. Allen Construction Services Company scheduled the meeting to discuss the bidding process and give information to interested local bidders.

Kendall welcomed the interested participants and opened the floor for each person to introduce themselves, and disclose what company, if any, they represented.

"As we go along, if there's any particular area of interest you are wanting to bid

on, feel free to ask questions," said Kendall.

Representatives of R.W. Allen were present to familiarize and educate those present on what is required for the bidding process.

Senior Project Administrator Tommy Goodyear, Project Manager Mark Day, and Project Estimator Drew Wren addressed the audience.

"I'm glad to see all of ya'll. This is a great turnout. Our goal is to get as many local sub-contractors and suppliers as we can involved in this project. It sounds like we've got a good representation of various needed skills, stone masonry, steel erectors, drywall, door installers, wood workers, plumb-
