He is a smart kid but makes poor choices. When he should be doing school work he just wants to play computer games. His former school decided to give him another chance. We his parents, teachers and church family have done all we know how to motivate him but it seems to no avail. We do not know what to do. We are open to any suggestions.

**Dear Mom,** I have a question for you: Who cares? You say, (1) your 15-year old son visits websites that he knows are off limits, (2) doesn't get his homework done unless you help him, (3) lies frequently, and (4) he is skating on thin ice whether he will be expelled from school a second time. So my question is, Who cares? Please don't think I'm being crass or unkind. The fact is, the wrong people care about his behavior. His parents care, his teachers care, his church

cares, but he doesn't care. The only people who care are not the ones who can solve the problem. Until the right person cares there is not likely to be much change.

I would suggest the following immediate steps. Remove his computer from his room. Remove his TV, Game-Boy, his music system and any other luxuries. If he has a cell phone, confiscate it. Remove any other privilege he enjoys. If he is eager to work toward receiving his driver's license, tell him that will be postponed for at least six months - only responsible people are permitted to drive cars.

When he has exhibited model behavior and his grades come up for one entire grading period you will begin to return the items he has lost, one a month - except the computer. Do not return the computer to his room; put it in a public place in the house. If he backslides, that is, if he gets a bad report from school, doesn't get his homework done, lies, etc., the process begins all over - from the beginning. We call it Leadership Parenting.

He will be angry. Good. Now the right person cares.


