## GSP confirms ID of Tate City car crash victim

Tate City - The Georgia State Patrol has received word of the positive identity of a crash victim who died Nov. 26th in a one-vehicle accident in Tate City, patrol officials said Monday.

Patrol spokesman Gordy Wright said David Marvin Wheeler, age 56, from Highlands, NC is the victim who perished in the crash.

The accident occurred on Tallulah River Road about 10 p.m., Nov. 26th, patrol officials said. Wheeler, driving northbound in a 2009 Chevy Silverado, lost control, left the roadway and the vehicle overturned, patrol officials said.

The vehicle burst into flames, Towns County Fire and Rescue responded to the crash scene, patrol officials said. Firefighters from neigh-

boring Rabun County also responded to the crash, patrol officials said.

Wheeler was burned beyond recognition and was pronounced dead at the crash scene by Towns County Coroner Ricky Mathis, patrol officials said.

Wheeler's remains were sent to the Georgia State Crime Lab for positive identification.

## County, cities head to court over L.O.S.T.

Towns County municipalities Hiwassee and Young Harris, have officially filed a law suit against the government of Towns County regarding the Local Option Sales Tax (LOST).

Commissioner Bill Kendall was served papers regarding the LOST litigation on regarding the complaint filed against the county by both municipalities.

A mediation hearing was held on Thursday, Oct. 25th, with mediator James Mahar, a Gainesville attorney specializing in mediation, meeting with both the cities and the county to work out a settlement regarding the LOST negotiations.

The negotiations broke down and there was no choice but to go into Baseball Arbitration for a resolution between the cities and the county.

Prior to arbitration, at the final negotiation hearing on Aug. 28th, Kendall made the following proposal. "I support and submit the committee's recommendation of not taking money away from anyone by keeping the formula for the past 10 years at 82 percent for the county and 18 percent for the cities to decide how to split their share."

At the mediation hearing, the county offered an 80/20 split to avoid litigation and the cities declined the offer.

Hiwassee Mayor Barbara Mathis said Hiwassee needs the money.

"In 2012, the LOST proceeds received by Hiwassee have resulted in a 2.033 roll back in city property taxes," Mayor Mathis said. "Due to the sales taxes generated in our city, Hiwassee property owners will continue to pay a net millage in 2012 of 2.270, the same millage levied since 2008. Receiving our fair share of the LOST proceeds is

of great concern to the Hiwassee Council," said Mathis.

Mathis added that the current tax division is clearly unfair to city residents and intended to benefit county residents to the detriment of city residents.

"It is regrettable that city residents cannot receive a fair division of the LOST dollars that the cities generate," she said. "I expect that the city residents will win, but regardless of the outcome, tax dollars that could be spent on needed services will go instead to lawyers and experts. This is a loss to the taxpayers."

Young Harris Mayor Andrea Gibby said the suit pulls at the heartstrings of Young Harris residents.

"It saddens me to know that we haven't been able to work through this negotiation," Mayor Gibby said. "We began this negotiation in good faith. We did not hire outside expertise until the end of the summer when the commissioner's expert presented for the county."

"That expert cut in half what the City of Young Harris has been receiving from LOST," she said. "After all the time that has been expended, it is time for a judge to help decide this issue. Either way, 2013 will be a new beginning for all of us."

Commissioner Kendall said that residents of Hiwassee and Young Harris also are
